


#### Human resources and training, coaching

We believe that our **staff is our greatest asset**, so it is important for our Company to invest in programs and initiatives that enhance the skills and knowledge of partners and professionals. All processes are aimed at ensuring the work of professionals in the best possible way. **Our approach to continuing professional development is based on targeted training programs, including audit, accounting and industry training in order to prepare professionals for new challenges.** 

All qualified auditors must be trained annually for at least 40 hours each year. In addition to this mandatory training, professional development of employees is carried out also through coaching and practical experience that they receive directly during the work. Providing opportunities for the right experience, learning and coaching helps them to develop and realize their potential with a changing rate of progress that satisfies them.

The purpose of programs is to assist partners and other professionals in maintaining and improving their professional competence level, ensuring systematicity and consistency in conducting of audit services. As an additional development at the workplace, Crowe Erfolg Ukraine, LLC provides formal programs for continuing professional development in relevant subject areas, that are consistent with the audit plan.

We have introduced the best practices in partnership with ACCA.



During 2021, human resources increased by 43% by joining our team of experienced experts with a high level of professional knowledge.



#### Human resources and training, coaching

We develop our professionals through appropriate coaching, on-the-job training, regular feedback, evaluation and other support activities under the supervision of partners and other senior team members.

Experienced professionals act as coaches for less experienced colleagues, thus creating a continuing learning environment. We also monitor the systematic appointment of our employees to perform certain engagements, which helps them to gain diverse experience in their development. We understand that, in addition to managing the professional development and effectiveness of employees, it is important to provide engagement teams with up-to-date information that will help them to perform their professional duties in a quality manner.

#### Remuneration

When hiring employees, Crowe Erfolg Ukraine, LLC has policies and procedures designed to ensure sufficient assurance that the Company will have sufficient partners and professionals with the level of competence and commitment to ethical principles necessary for:

- √ implementation of projects in accordance with the established requirements for the relevant engagements,
- ✓ ensuring conditions for the issuance of reports of appropriate quality.

The remuneration of key partners is determined based on the evaluation of the results of each partner's work performance for the relevant year. The remuneration of a key partner consists of two elements.

The underlying component is a salary. The amount of the underlying component reflects the functions and job responsibilities of each key partner. The additional component is determined depending on the performance of each key partner for the year compared to previously agreed individual goals. Our policy on this variable portion of key partners' remuneration takes into account a number of factors, including work efficiency, quality of services provided to clients, profits and profitability growth, leadership qualities and commitment to Crowe Erfolg Ukraine, LLC values. Also, it is determined by the results of the assessment of their ability to ensure the quality of the audit.








Revenue of the Crowe Global network for 2021 amounted to

#### **Quality assurance system**

The international Crowe Global network considers quality in professional activities as a fundamental basis of its aspiration to leadership. The members of the network are aimed at achieving professional excellence and providing excellent services to their clients, in particular through cross-border cooperation.

Crowe Erfolg Ukraine, LLC is aimed at providing high-quality services that meet the needs of customers and society. Together with the awareness of professional responsibility, this aim determines the Company's movement towards continuous improvement of its quality control system.

The internal quality control system of services provided by Crowe Erfolg Ukraine, LLC is based on the compliance with the Law of Ukraine "On Audit of Financial Statements and Auditing", International Standards on Quality Control, Auditing, Review, Other Assurance and Related Services, primarily the requirements of the International Standard on Quality Management 1 (ISQM 1) and the International Code of Ethics for Professional Accountants of the International Federation of Accountants.

ISQM 1 requires an audit firm to establish and maintain a quality control system that provides reasonable assurance that the firm and its personnel comply with professional standards, applicable laws and regulations, and that the auditor's reports provided are specific. To this end, Crowe Erfolg Ukraine, LLC has developed and implemented an internal standard "Regulation on the quality control system of audit services", which defines the basic policies and procedures that ensure compliance with legal requirements and professional standards, consistent provision of high-quality professional services.

#### The structure of implemented policies contains the following elements:

#### 1. LEADERSHIP AND MANAGEMENT RESPONSIBILITY

The quality control system is managed through the setting of priorities, allocation of responsibilities and establishment of responsibility for the implementation of procedures established by internal regulations.

The CEO of Crowe Erfolg Ukraine, LLC approves documents, which establish the basic policies and procedures of the quality control system, appoints a person responsible for the functioning of such system, monitors the compliance with established requirements by partners and employees of the Company. The Company's management by its own example demonstrates a commitment to the highest standards of professional activity, compliance with quality requirements and ethical principles and has the ultimate responsibility for overseeing the operation of the Company's quality control system.

#### 2. COMPLIANCE WITH THE PROFESSIONAL ETHICAL REQUIREMENTS

The fundamental principles of honesty, objectivity, professional competence and due diligence, confidentiality and professional conduct, defined by the International Code of Ethics for Professional Accountants, underlie the actions of Crowe Erfolg Ukraine, LLC aimed at developing of relationships with employees, customers, government authorities and society as a whole. The Company is constantly developing its quality assurance system of professional services, helps its staff to develop, motivates them to interact and help each other, controls risks and circumstances that may adversely affect the objectivity of judgments. We strive to make our services valuable to our customers and society. The internal requirements for maintaining the confidentiality of information act in such way as to ensure the security of the interests of the Company's customers, as well as its employees. Information collection procedures have been implemented in order to assess properly the independence of the Company and its employees, and there is a system for exchanging information with other members of the Crowe Global network on the provision of services to public interest entities, which allows to monitor compliance with the requirements of the legislation on the restriction of the provision of other services except for audit services to clients. The Company has established procedures for identification and evaluation of threats to the independence by both the Company and its partners and employees, as well as the obligation to inform responsible persons and document the implementation of such procedures.

#### The structure of implemented policies contains the following elements:

#### 3. ACCEPTANCE AND CONTINUATION OF RELATIONSHIPS WIITH CLIENTS

Consideration of the issue on the approval of a new client or a new project from the existing client of Crowe Erfolg Ukraine, LLC is carried out with taking into account the requirements of independence, which are applied to the Company, its employees and other members of the Crowe Global network. The decision to cooperate is made on the basis of analysis of comprehensive information about the potential client, its activities, contacts, key managers and related parties. The Company assesses the impact of other network members' relationships with each client, including the provision of non-audit services to audit clients. The control over the compliance with the restrictions established by the legislation concerning the terms of cooperation with the client in the statutory audit engagements, including the provision of services to such clients by key audit partners, concerning the remuneration for services to the statutory audit clients is also introduced. Responsible attitude to the relationships with the client is that the decision to cooperate is made on the basis of a proper assessment of the client's real needs in audit services, its honesty with the auditor, the availability of sufficient resources of the Company to perform a high-level audit project.

#### 4. AUDIT PROJECTS IMPLEMENTATION

In order to implement each audit project, Crowe Erfolg Ukraine, LLC appoints its manager – an engagement partner. It is a person who has an appropriate competence to ensure the proper organization of work and to achieve a quality result and makes key decisions regarding the organization of the project implementation. When performing services on the statutory audit of the financial statements, the engagement partner is a person who, in addition to sufficient experience and knowledge, has the qualification of an auditor in accordance with the Law of Ukraine "On Audit of Financial Statements and Auditing". The work of employees involved in a specific engagement is a subject to supervision by the engagement partner or other experienced employees. This practice increases the reliability of identifying all significant risks of the project, allows to plan its implementation more effectively, promotes the exchange of experience and staff development. In order to resolve complex issues, the engagement team has the opportunity to seek advice from relevant experts of the Company or conclusions of the external experts. The audit process is organized using advanced software products CaseWare and other developers. The documentation process is performed in templates offered by such software products and developed by the Company's experts taking into account the requirements of the Ukrainian legislation and best professional practices. Audit engagements are subject to the internal control (review) by a competent person not involved in its acceptance and implementation. Such person reviews the compliance of the work performed and documentation prepared as a result of the work with the requirements of the legislation, professional standards and internal regulations of the Company. A review of the quality of the statutory audit of the financial statements of the public interest entities or review of the financial statements is performed prior to the issuance of the auditor's report. In the engagements of the statutory audit of the financial statements of public interest entities, the quality controller considers compliance with established policies during the acceptance of the engagement, reviews the planning documentation and checks the implementation of the engagement at the final stage.



## The structure of implemented policies contains the following elements:

#### 5. HUMAN RESOURCES

The quality of services of Crowe Erfolg Ukraine, LLC is based on the competence of the personnel involved in their implementation. The appointment of employees to perform the audit project is based on their knowledge, experience, skills and development opportunities. Sufficient number of competent employees is provided through the recruitment policies of employees with the appropriate level or with the potential for development, continuous training, motivation. The Company regularly organizes events for the professional development of its employees, uses the training resources of the Crowe Global network, assists its employees to receive education and knowledge about advanced professional practices.

#### 6. MONITORING

The quality control system established at Crowe Erfolg Ukraine, LLC is under constant review in order to respond in a timely manner to changes in the regulatory environment, to identify deviations from the established requirements in order to improve existing and introduce new processes. Study of the functioning of each element of the quality control system of audit services, the compliance of such system with current requirements and advanced practices is carried out annually. Its effectiveness and consistency in the performance of individual engagements, compliance by each person performing functions of an engagement partner in the audit of the financial statements with defined policies and quality assurance procedures, are reviewed during the study. The results of the study are reviewed by the Company's management and its senior staff and are used for further development of the quality management system.

# **International Standards on Quality** Management

Since 15 December 2022, the International Standards on Quality Management (ISQM) of audit services will come into force, which are aimed at improving the reliability of audit quality assurance systems.


Crowe Erfolg Ukraine, LLC plans to implement these standards by that date. New requirements stipulate that audit entities, while building their systems to ensure the quality of audit services, should transfer from monitoring of compliance with the established requirements for the performance of such services to defining quality objectives, timely identification of risks of achieving such objectives and establishing of procedures in response to these risks or identified facts of deviations. The system should take into account both the general requirements for each audit entity and the nature and circumstances of its activities, its specialization, the requirements of its audit network.

Since November 2021, Crowe Erfolg Ukraine, LLC has begun the process of monitoring the existing policies and procedures of the existing quality assurance system in order to identify necessary changes, update documentation and implement procedures in accordance with the requirements of ISQM. This work is carried out in close cooperation with Crowe Global, which in connection with the implementation of ISQM sets the requirements of the network to its members, provides them with recommendations and their own tools to assist in the process of systems updating.

#### **Rotation policies**

The Company's policies provide the mandatory replacement of the engagement partner of the statutory audit of the client's financial statements, if one person has continuously performed such functions during seven years. The interruption in the performance of such functions in relation to a particular client must be at least three years.

In respect to other members of the group engaged in conducting a statutory audit of the financial statements of one client, there is a gradual rotation so that one person is involved in the implementation of procedures for the same aspect of work for no more than seven consecutive years.






