We are pleased to present our regular Transparency Report for 2024, which demonstrates our commitment to the transparency and integrity principles, as well as high standards of doing business. This document is more than just a regulatory requirement, it is an in-depth review of our audit and assurance business for the past financial year that provides investors, organizations, audit committees and audit professionals an understanding of the actions we have taken for quality maintenance and improvement, introduction and measurement of our goal-oriented corporate culture, as well as for sustainable development of our business.

Transparency and accountability are at the foundation of everything we do. We are aware of the importance of integrity, ethical conduct and risk management to ensure the trust of our customers, society and regulators.

This report contains **detailed information** on our corporate governance structure, quality control methods, independence policy and results of the audit quality monitoring.

We made significant progress in 2024. The firm continued to grow and the revenue for 2024 amounts to **UAH 118 million**, which is 60% more than in the previous year, due to the proportional increase in the number of our clients and the expansion of the range of services we offer.

Statutory audit remains central to the firm's activities and generates more than **55%** of total revenue. We significantly expanded our cooperation with state-owned entities and became one of the leading audit firms providing services to the energy sector. Special tax conditions for the IT industry and certain areas of the military-industrial complex contributed to the development of the assurance services for Diia City residents.

In 2024, we also introduced services to assist in the **SAF-T UA** formation and prepare clients for tax Eaudit. We are preparing for the implementation of sustainability reporting and its audit in Ukraine





QUALITY MANAGEMENT SYSTEM

The Company has implemented a quality management system (QMS) based on the requirements of the Law of Ukraine№ 2258-VIII and International Standard on Quality Management (ISQM) 1 "Quality Management for Firms that Performs Audits and Reviews of Financial Statements, or Other Assurance or Related Services Engagements" and applies approaches developed by the Crowe Global network and our company.

The Company has defined quality goals and integrated them into all processes of its activities. We recognize that quality is the basis of our professional activity. We strive that every member of our team and every service provider to our professional activities understand and affirm their responsibility to achieve this goal. We have identified and assessed the risks that may prevent the achievement of the defined quality objectives and, accordingly, have established processes in which actions are integrated to prevent or detect the occurrence of risks in a timely manner. The relevant policies and procedures are described in the internal QMS documentation and implemented through the organization of employee responsibility, resource allocation and information exchange. As managers of the Company, we recognize our responsibility for the implementation and maintenance of the QMS, define the roles of each of our managers and other employees in the proper functioning of this system, and develop culture that is designed to maintain the level of our services at a high level.

Our actions are aimed at identifying quality risks in a timely manner and establishing policies and procedures that address these risks. We demand appropriate ethical behavior and compliance with the requirements of independence from ourselves and other employees of the Company. The process of accepting clients and specific assignments and continuing to have relationships with them requires professional responsibility, integrity and avoidance of situations where financial or operational interests may outweigh professional responsibility. The Company is continuously developing its approaches to performing its professional tasks, ensuring the development and proper management of resources and information necessary for the provision of quality services and the functioning of the QMS. Provision of quality services requires a high level of competence of our employees, so we invest in training and development of our employees. strengthen cooperation with other organizations that reliably meet the need for expertise, information and technological resources. A well-functioning QMS implies regular assessment of our progress and actions for continuous improvement

QMS MONITORING



In accordance with the requirements of ISQM 1, as at December 15, 2024, the procedures for the general assessment of the functioning of the implemented QMS were completed. Based on the review of how the implemented quality policies and procedures functioned, it was concluded that the Company's quality management system ensured the achievement of the defined quality objectives and the risk that the quality objectives would not be achieved was at an acceptably low level.

Independence assurance

The Company's independence policies and procedures are determined by the requirements of the IESBA Code and Ukrainian legislation. These requirements relate to the relations of the Company, its personnel and experts engaged by it with clients and related parties. Attention is paid to the personal independence, financial and labor relations, terms of cooperation and established restrictions on the provision of other services to the statutory audit clients by the Company and other members of the network to which it belongs.

The Company's policies and procedures ensure:

1

understanding of the requirements for independence by persons involved in accepting and performing professional tasks

2

confirmation by all employees that they meet such requirements

3

the obligation of the Company's employees to document and report facts and circumstances that they become aware of that may be considered a threat to independence



The independence requirements are also applied to the experts involved and service providers, including other firms within the Crowe Global network. Procedures for review and confirmation of compliance with the established independence requirements are implemented in the processes of accepting a client and considering the continuation of cooperation with it and in the performance of audit engagements.

These procedures include: study of clients and tiheir relationships using tools and data created by the Company, provided by the Crowe Global network, or purchased from Ukrainian Know Your Customer (KYC) system providers. The engaged personnel also inform the Company of any known threats to their integrity both during their engagement and upon completion of their tasks and provide annual confirmation of their understanding and compliance with the established integrity requirements

During the annual monitoring of the functioning of the Company's quality management system, the Company assesses how the processes are functioning to ensure compliance with the established integrity requirements.

Audit of the Quality Control System

In 2024, the quality control system established by the Company was audited by the Crowe Global international audit network.

The Company passed an external audit of the quality control system of audit services in January 2025, as a result of which the State Institution "Public Oversight Body for Audit Activities" issued Order No. 23-κπ dated April 14, 2025 "On Passing the Quality Control Audit", in which it recognized CROWE ERFOLG UKRAINE as having passed the audit of quality control of audit services with binding recommendations"



Rotation policy

The Company's policies provide for mandatory replacement of the partner engaged in the statutory audit of the client's financial statements if one person has been performing these functions continuously for seven years.

The interruption in the performance of such functions in relation to a particular client must be at least three years. As for the other members of the group engaged in conducting of a statutory audit of the financial statements of one client, there is a gradual rotation so that one person is involved in the same aspect of the work for no more than seven consecutive years.

Key Partners Remuneration

The remuneration of key partners is determined based on the results of an assessment of the performance of each partner for the relevant year. The key partner remuneration consists of two elements.

The base component is a salary. The amount of the basic component reflects the functions and job responsibilities of each key partner. The additional component is determined based on the performance of each key partner for the year against previously agreed individual goals.


